Eating challenges are inherently dangerous activities, and all participants expressly and voluntarily assume the risk of any and all injury and damage that may result from the participation in eating challenges. Participants understand that such risks include, but are not limited to possible bodily injury, partial or total disability, paralysis, death or other injuries or damages. Each participant shall bear and accept all the risks of mental, physical, and health damage or bodily injury. Participants will be required to execute a Waiver of Liability, Release, Assumption of Risk and Indemnity Agreement before participation.

RULES

- 1. Giant Ramen Eating Challenge is opened to all amateur eaters eighteen (18) years or older who are in good health. Professional eaters, persons recognized by the AICE, the IFOCE or members of any professional eating organizations are not eligible.
- 2. Any individual with a serious ailment or health problem may not enter the challenge.
- 3. One order (4 servings of designated ramen choices, vegetable ramen excluded) per person.
- 4. Participant needs to finish all of the noodles, toppings, and broth by himself or herself within the 30 minutes challenge time.
- 5. Participant may eat sitting down or standing up in the designated area. Participant leaving his/her designated area during the challenge will be disqualified.
- 6. If the participant vomits or regurgitates outside of their mouth at any time during the challenge, he or she will be disqualified.
- 7. No restroom or other breaks during the challenge.
- 8. Must remain at the table for 5 minutes after completion of challenge.
- 9. Participant agrees to be charged for full price of the order if he/she fails the challenge.
- 10. One completed challenge per person per year is allowed.
- 11. Anyone successfully completes this challenge will be eligible for Giant Level: 5 servings challenge anytime.
